Cynthia asked the status on the archaeological study for HS #4 land.

Hector Gonzalez stated that 20% of our HS #4 property that might have artifacts. The District paid a company to come out and complete a report and there isn't anything major as of now. Once the report is complete a copy will be sent to the Pechanga Tribal. If something is found we have an agreement with the tribe that we opt to give it to them.

Fred Good stated that there is a state bond measure that is on the ballot in November and is confident that it will pass.

**Other Facilities Update:**

Sheila Curtis stated that there are 2500 new homes that are going to be built within the next three years in our HS #4 area.

Fred Good stated that HS #4 and MS #2 plans are in the final stages of approval at the state.

Sheila Curtis asked if we can move forward and push for another bond measure in the future to complete HS #4 and MS #2? Fred Good stated that we could and it's something that can be brought up in the future.

Eric Kroenke stated that it is difficult to educate people on the importance of a bond.
